## DIRECTOR OF TAXATION, STATE OF HAWAII'S MEMORANDUM IN OPPOSITION TO BOOKING.COM B.V.'S MOTION TO SEAL TRANSCRIPTS

Director of Taxation, State of Hawaii ("Director") notes that, although Booking.com B.V. ("Booking") makes one reference to "tax return information" in the motion pending before the Tax Appeal Court, Booking presents no affirmative argument either here or before the Tax Appeal Court that the information at issue in its Motion to Seal is tax return information.<sup>1</sup> Instead, Booking's arguments rest entirely on assertions that the information is confidential or a trade secret. Based on that understanding, the Director respectfully submits the following:

As there is no independent statutory requirement prohibiting the public disclosure of information at issue here, the Director agrees that, to the extent that the information in question was actually disclosed in open court with members of the public present, the hearing cannot be retrospectively closed. The Director also agrees with Public First that information available to the public on Booking's website also cannot be a trade secret or confidential information. Dkt.
