Given the heinous nature of the numerous sexual assault offenses that this inmate committed against multiple innocent women, the Department of the Prosecuting Attorney maintains its strenuous objection to the release of inmate John Freudenberg on parole. We respectfully refer the Hawai'i Paroling Authority to our previous correspondences dated September 1, 2017 and August 25, 2020.

This inmate is a serial rapist who terrorized our community by violently victimizing 16 different women over the course of 1 year. This inmate gained entry into the homes of the victims and terrorized the women by choking and threating to kill them, and raping and sodomizing them while holding them at knife point. The depraved actions of this inmate left the victims with physical injuries and a lifetime of emotional scars. The depraved actions of this inmate left his victims feeling vulnerable and unsafe in their own homes, and unable to shake the horrifying details of their assaults.

Because of the sheer volume of victims and extremely violent nature of this inmate's criminal behavior, this inmate was sentenced to 12 life terms of imprisonment. His sentence reflects the sentencing Court's intent to provide just punishment for this inmate and protect our community from his callous, predatory behavior. Thank you for allowing the Department of the Prosecuting Attorney an opportunity to be heard on the request for parole by inmate John Freudenberg.

When we last met on Mr. Freudenberg's case on March 14, 2017, several comments were made which the State would like to address in an effort to reaffirm our position which has, and continues to be, a complete objection to the early release of Mr. Freudenberg from his life sentence.

While we will not rehash all the arguments made during the prior parole hearing, we would highlight the following:

1. Mr. Freudenberg argues that the State is surreptitiously commuting his life with the possibility of parole to life without the possibility of parole. Here, defense misses the point. Presently, Mr. Freudenberg has served 35 years out of 12 life sentences imposed by the court. Thirty five (35) years does not equate to 12 life sentences. It does not even equate to one (1). Yes, his sentence was with possibility of parole, but it can hardly be said that 35 years of incarceration is unreasonable given the nature of the offenses.

So the question is when is parole appropriate, if ever? We submit, parole is not appropriate at this time. His 12 life sentences is an absolute reflection of the severity of the crimes he committed and the number of victims he terrorized and sexually assaulted. While Mr. Freudenberg may believe, he has paid his "debt" to his victims and society, his statement is self-serving. It lacks any appreciation of the impact his crime has had on his victims, this State and the reason the court imposed the lengthy sentence.

As we see it, 35 years for each victim, is hardly payment of a "debt" owed. There were 15 victims and these were separate and very distinct instances of harm committed over the course of approximately 1 year. With each instance, Freudenberg had an opportunity to stop his behavior, and conform to the requirements of the law. However, with each instance he grew more bold, and more exhilarated by his actions. Given these special circumstances, each instance, each victim is deserving of far more than the time he has currently served. Indeed, the court recognized this when it handed down its sentence.

2. Freudenberg seeks parole without having had the benefit of work furlough, arguing that the Department of Public Safety is refusing to allow him an opportunity to establish a track record of law-abiding behavior. However, Freudenberg forgets the importance of why he was given 12 life sentences. He poses a danger not only to his victims, but also to the community at large. The Department of Public Safety ("DPS") as well as the prosecutor's office has an absolute obligation to assure and advocate for the safety of the community at large.

We do not want history to repeat itself, and while we cannot predict it will or not, we cannot ignore what did happen and unsuspecting women, who were safely within their homes, lost all sense of security. While the facts of each case have been re-stated repeatedly, and the trauma of each incident may have faded for some, the Board can be reassured that many victims and many within our community have not forgotten. Yes, we strenuously object to his release. Yes, he is a danger. Yes, public safety is at risk if allowed back into our community.

3. The fact that the Board recommended the Inter-State Compact transfer of Freudenberg to Texas does not mean that he should therefore be released here. As Mr. Tua pointed out, "resources" played a role in the Board's decision to release Freudenberg to Texas jurisdiction. The fact that DPS is unable to come up with a viable work furlough plan is evident that we lack adequate resources within our own community to vigorously monitor Freudenberg if released. This is concerning since he will be released within our community should be granted.

Freudenberg unfairly characterizes this as a sinister plan to keep him incarcerated; once again, failing to recognize just what is at stake. Community safety. If we as a State do not have adequate resources to safely monitor him under the work furlough program, then why should he be considered for parole? More important, Mr. Freudenberg was to develop his own plan for release, which of course, the Board will evaluate and scrutinize. A plan that has not been shared with the State as of this writing.

We assert there is no reason to consider him for parole until proper resources become available and a safe plan developed to monitor him. There is no reason to put the community at risk, when we already know what he did and is capable of. More important, there is no reason to risk public safety when we know we lack the resources (work furlough) to monitor him.

Who knows what resources will become available, next year, in 5 years, in 10 years. Surely, we cannot afford to put the cart before the horse in this situation.

4. Mr. Freudenberg also argues that he has done well, by completing sex offender treatment 5 times, and now helps with the sex offender program and works as an electrician, keeping "this place lit". Attributes, he is proud of. However, his contribution to society, behind prison walls is something that he can continue to pursue. What is the harm of having him do all the things, he apparently is good at, right here in this facility? Giving him an opportunity to use his "talents" outside the facility, does little for the community in comparison to the risk his release has on public safety. The fear it strikes in the heart of the community is real, it was back then, it is now. While this may make it difficult for Freudenberg, we should not forget we all got here, because of him.

The Department of the Prosecuting Attorney strongly objects to the parole of Mr. Freudenberg for the reasons stated above and respectfully asks the Board to consider the impact his release will have on public safety.

This office maintains its position that Inmate John FREUDENBERG ("Inmate") should serve the full term of his incarceration and that any request for parole by the Inmate should be denied. Inmate FREUDENBERG is a serial rapist, who victimized multiple women over time essentially paralyzing the Manoa community as police actively sought to apprehend him. To reflect the extent of his offences, Inmate FREUDENBERG was sentenced to 12 life terms. Accordingly, Inmate FREUDENBERG is not an appropriate candidate for parole because he continues to pose a danger to the community as demonstrated by the copious amount of sexual assaults he has committed. Despite his completion of the sex offender treatment program, treatment does not guarantee that he will not re-offend. Given Inmate FREUDENBERG's disregard for the public's safety, his multiple victims, and inability to control his deviant behaviors, the likelihood of recidivism is ever present. It is the recommendation of this office that the Hawaii Paroling Authority deny Inmate FREUDENBERG's parole request and require him to serve the full term of his incarceration.
