- III. DHS Reports to CRP | Florence Calderon
 - New Director: as of May 9, 2023 Ryan Yamane, MSW
 - Assistant Director: Trista Spears overseas Social Service
 - So far transition to new leadership is going well
 - Legislation:
 - Approved shortage differential for social workers
 - Shortage will go into positions that are hard to fill (i.e. assessment workers/specific counties Maui, Hilo, Kona)
 - Added to salary for limited time
 - Only for social workers
 - Hazard pay was approved for staff that worked March 2020 to 2022
 - Based on hours/days worked to qualify
 - Upcoming Audits in 2025
 - CSFR
 - o Title IV-E
 - Civil Beat article regarding recent audit regarding placement of children
 - o DHS is working on the recommendations made in the audit
 - State contracts are rarely monitored/Federal contracts are more closely monitored
 - DHS has over 100 contracts/Flo oversees 1/3 of these contracts

- Also covering for PDA that are out
- Flo is overseeing Hale Kipa contracts
- DHS is looking at making oversight of contracts a priority
- CSFR Report is a priority: Deadline is coming up soon
- Good new: Number of children entering foster case has decreased with FFH and number of Native Hawaiian in foster care have also decrease
- CQI has completed Hilo review
 - Forward CQI schedule
- CRP Budget
 - Elida and Maria are working on remainder of this year's budget minus
 February and May travel
 - Approximately \$5000 left. Funds do not roll over
 - Plants?
