Delia Fabro-Miske, by her counsel, Marcia A. Morrissey and Donovan A. Odo, respectfully submits this Sentencing Memorandum, which has been redacted pursuant to Federal Rule of Criminal Procedure 49.1(a). An unredacted version was filed on April 7, 2025.

I. Delia Fabro-Miske's Personal Background

A. Childhood

Delia is the daughter of Warren Fabro ("Warren") and Lorraine Benison Fabro Suankum

("Lorraine"). Her paternal grandparents emigrated to Hawaii from the Phillippines and instilled in their children strong core values of "honesty, hard work and family." Exh. A (John M. Hayashida letter). Lorraine and Warren were living in New York and when she became pregnant with Delia and her twin sister, Caliegh, they moved back to Hawaii, so their children would be raised "where Ohana and Aloha were fundamental and important." Exh. B (Warren Fabro letter), p. 2. When Delia was only four years old when her parents separated and divorced. *Id.*, p. 4. Although divorce is always difficult for children, the divorce and Lorraine's subsequent marriage to Arkom Suankum changed Delia's life for the worse. She had been close to the Fabro family, but after the divorce, Lorraine "kept the children away from [the] extended family." Exh. C (Liberato D. Fabro letter). Despite "many attempts to remain close to Delia while she was growing up," "her mother made that next to impossible." *Ibid. See also* Exh. D (Cindy Johnson letter) ("Delia was isolated from her father and his extended family most of her childhood years."). Warren Fabro describes how this happened:

The breakup and the subsequent experiences were difficult for Delia and her siblings. Raising children in a broken marriage is a difficult process. I tried to avoid arguments with her mother, and, for the sake of my children, I often capitulated to my ex-wife's demands which led to my children oftentimes being isolated from me for long stretches of time. There were many family dinners at my house (i.e. Thanksgiving and Christmas) where, although the [y] were to spend them with me, they were instead kept by their mom. Sometimes, I believe this was done out of spite. Regardless, I chose not to escalate these situations with arguments to shield my children from any chaos. Please understand that my ex-wife was not well. She suffered from mental health issues including being diagnosed . I realize that my ex-wife tried her best as we with all do as parents. I am only learning recently of her details of her behavior, especially her temper and its effect that it had on my children, especially Delia. In retrospect, I now see that the environment that she was raised in with my ex-wife contributed to her being isolated from me and my

family which, in turn, deprived her of guidance and direction from me and my family. I have regrets for not being forceful in certain areas and now see that I could have done a better job as her father.

Exh. B, p. 4.

Kathryn Benison, Lorraine's sister, writes that "Delia did not have a typical childhood as my sister was mentally ill." Exh. E (Kathryn Benison letter), p. 1. After the divorce, Lorraine "emotionally and ultimately physically separated" Delia from her father. She "turned her children against Warren by "extreme emotional manipulation." Delia and her siblings had to address her new husband, Arkum Suankum, as "dad." Warren was to be called "DW or daddy Warren." Even worse, once Lorraine married, "Warren was shut out and not permitted to have regular interaction with the children." *Ibid*.

Although Lorraine had good qualities,¹ "she could be cruel, controlling, mentally, verbally, and physically abusive to her children." She kept a stick above the door that she called the law: "[i]f you broke her laws, the law broke you." Exh. E, pp. 1-2. Delia's cousin, Amanda Khozouri, Psy.D., describes Lorraine as "an uncontrollable and unpredictable mother" because of her "untreated mental health issues." Exh. F (A. Khozouri letter), p. 1. Delia had to "do as she's told without asking why otherwise she suffered the physical consequences." *Id.*, p.1.

Delia "was required to be the adult in the household." She was responsible for cooking and cleaning and taking care of her younger siblings. Yet despite having significant responsibilities, Delia assumed "was not permitted to have an opinion ever." Exh. E, p. 1.

According to Amanda Khozouri, Delia "has been living in survival mode for most of her life, and

Kathryn Benison describes one side of Lorraine as "intelligent, entertaining, funny, witty, charismatic and generous to a fault with her time and talents." Exh. E, p. 1. Amanda K. Khozouri remembers her aunt as "remarkable and whimsical." Exh. F, p. 1.

she coped through compartmentalizing." Exh. F, p. 1.

Loraine "worked infrequently" and Suankum was a guitar player who taught music at Saint Francis School in exchange for free tuition for the children. Neither he nor Lorraine made enough money to cover all their expenses. Lorraine taught Irish step dancing to Delia and Caleigh, and they performed in the streets of Honolulu for money to feed the family. When her brothers were old enough, they joined their sisters in dancing for subsistence. Exh. E, p. 1. To Delia, it seemed their "lives revolved around when their mother needed them to perform." PSR, p. 30, ¶ 102.

Unsurprisingly, Irish step dancing did not bring in enough money to support the family. "When food was short, the children were told they were fasting for whatever sins [Lorraine] could think of." Exh. E, p. 2.

Those who knew Delia as a young child describe her as "gentle, kind, loving, caring, and eager to please." *Id.*, p. 1. The hardships of Delia's upbringing did not make change her nature; on the contrary, she "remained soft and sought kindness in others." Exh. F, p. 1.

B. When Delia Met Caleb

In 2011, when Delia attending Saint Francis High School, she met Caleb Miske. He was her first boyfriend. Kathryn Benison describes Caleb as "a nice boy" who "swept [Delia] off her feet." Exh. E, p. 2. Amanda Khozouri writes that Delia "saw the future with Caleb Miske in the way a little girl waits for prince charming, and he quickly became her everything." Exh. F, p. 1. It was not necessarily easy to date Delia, because she was responsible for her siblings, and a date with her often involved her siblings as well. But Caleb was kind and patient.

After Delia graduated from high school in 2013, her life with her mother became

untenable. She cooked, cleaned and took care of her siblings, but still harshly treated by her mother. Delia asked Caleb if she could live with him and his father. Both Caleb, who called her "Cinderella" because of her mother's treatment of her, and Mike agreed. Delia's life with the Miske family was better than living with her mother. She was not hungry, did not have to dance for money, and was free from her mother's abuse.

Life with Mike Miske was, however, not idyllic. He was strong willed and controlling. Caleb and Mike frequently clashed. Delia and Caleb moved out of Miske's house more than once. They shared a townhouse with Jonathan Fraser and Ashley Wong on Leowahine Street, but were evicted when Jonathan and Ashley could not pay their share of the rent. After that, the four of them were allowed to sleep in Miske's office on Queen Street, but had to leave before working hours began; it was during this time Jonathan took Miske's Rolex watch.

C. Delia's Pregnancy, Caleb's Accident, and No. 's Birth

In June 2015, Delia became pregnant. She and Caleb were living in an apartment on Kalihi Street. They were married on October 10, 2015.

In early November, Caleb and his father quarreled about Caleb's poor work ethic, and Miske took Caleb's truck away as a punishment. Delia and Caleb moved in with friends, which is where they were living on November 11, 2015, the day of Caleb's accident. Delia continued to live there until N was born, one month early, on 2015. After Delia and N were released from the hospital, they moved to her mother and stepfather's apartment on Victoria Street, because it was close to Queens hospital. Delia spent a lot of time at the hospital, and before Caleb's condition deteriorated, N met her father and Caleb was able to hold his daughter.

[Delia] was glowing and so full of life. She and her other half, Caleb, were young and in love and about to have their first child. Within a few months of knowing her I witnessed her transition from an expectant young mother, to a newlywed, to widow[] and single mothers. Despite all of this she never failed to prioritize New put her family first and remain resilient.

Exh. G (Bronte Kaneakua letter).

D. Delia's Life After Caleb's Death

In anticipation of Caleb's release from the hospital, Mike Miske found the apartment on Keokea Place in Hawaii Kai; it was chosen because Caleb would be in a wheel chair and needed to be on the ground floor. But that was not to be.

In the early summer of 2016, Delia and N moved into the Keokea Place apartment. She was a recently widowed mother of a young, daughter. She was also totally dependent on Mike Miske. Kathryn Benison writes that although Miske "shared Delia's grief with the loss of his son and quickly embraced Delia and N," the effect of his taking her and N under his wing had a darker side:

[Delia] was a young mom, who was widowed with a baby (who was born). She was grieving and heartbroken, alone with nowhere else to turn and no money. She felt fortunate that [Miske] let her work in his office and help take care of the baby. Things quickly turned as he took control over her life, and she was no longer permitted to see people other than him and his family. Delia was numb and operating in a state of depression, grief and simply overwhelmed.

Exh. E, p. 2.

Mika'ela Williams is Mike Miske's daughter. She notes that "[a]lthough Caleb and I share the same father, I was raised by my mother and step-father in a different home and with a

different lifestyle." Exh. H (Mika'ela Pertzoff-Williams letter). Nevertheless, she and Caleb "were extremely close," and she became very close to Delia as well. "[Delia] became my sister in love, long before she became my sister-in -law." Mika'ela describes the change in Delia after Caleb's death as "heartbreaking:"

> I could see that [Delia] was operating out of fear in an extremely controlling environment. I am close to my father, Mike Miske, and do love him. However, I recognize the power he has over people. To advise her to separate herself from that family is a lot easier said than done, and, if I'm speaking candidly, I believe it was a dangerous but essential choice. However, I recognize that she chose to remain a part of that family, and I know she regrets the degree in which she was.

Exh. H.

In 2016, Delia, N and Lorraine traveled to New York, where Kathryn Benison and her daughters lived, to have N baptized in the Catholic Church and introduce her to Mike's daughter, Mika'ela, who was attending college on the East Coast. Exh. E, p. 2; Exh. F, p. 2. 's baptism was important to Delia, who was raised Catholic and attended Catholic schools. Delia chose cousin Amanda Khozouri to be N 's godmother. Mike Miske did not seem to understand that this was a religious ceremony, and Kathryn believes he feared Amanda would have control over Delia by virtue of being her godmother. Exh. E, p. 2. Mike kept Face Timing Delia, telling her to come home. *Ibid*. It appeared to Amanda that Delia was "operat[ing] out of fear, the same way she had as a child." Exh. F, p. 2. "The phone didn't finish the first ring before she answered the dozen calls that came daily from Mike Miske. He tracked her every move, threatening her that this would be the last time she would travel with her own daughter to see her family." Ibid. This was the last trip Delia took to see Kathryn Benison and her

daughters.

On August 22, 2016, Mike Miske filed a

of the First Circuit, State of Hawaii. Exh. I. He told Delia that the limited guardianship would insure he provide financial support for her and N, and she agreed to the appointment, without advice from or representation by separate counsel as to what it meant. In fact, the order appointing Guardian with Limited Authority issued December 21, 2016, gave Miske "unlimited authority" to make decisions about N 's support, care, education, health and welfare that he would not have otherwise had. For example, he had the right to "reasonable and consistent visitation/contact with the Minor;" to "take custody of the Minor and establish Minor's residence;" and to consent to her medical care and treatment. *Id.*, at p. 4. Warren Fabro writes about Miske's appointment as N 's guardian:

Mr. Miske filed documents with the of the First Circuit naming himself as the guardian of my granddaughter should something happen to my daughter. This guardianship was approved by my daughter at the time as she was under the control of Mr. Miske. Had I been aware that this guardianship was under consideration, I would have vehemently contested it. Fortunately, I recently filed my own petition (Pro Se as no attorney I knew wanted to help for fear of retribution by Mr. Miske) to name me as my granddaughter's guardian in the event something happens to Delia. The

Exh. B, p. 4.

Kathryn Benison writes that after Caleb's death, Miske "was in control and Delia followed orders." Exh. E, p. 2. She worked at Miske's office into the evenings on most days. Her contact with her mother and siblings was limited to Friday nights, when they were permitted join the Miske family at Maunalua Bay to lay a wreath for Caleb in the water. *Ibid*.

Miske's control over Delia was such that when her cousin Emily Khozouri visited Hawaii with her mother, they had little contact with Delia without someone from the Miske family being present. Emily writes that "[c]ar rides would be interrupted by phone calls asking for estimated time of arrival and exactly where we were if we weren't directly in their line of sight." Exh. J (Emily Khozouri letter), p. 1. She describes one day when she and Delia left their phones in the car to take a sunrise hike and swim. Although they were without the phones for perhaps an hour, when they returned there were multiple phone calls from Mike and his family. Emily describes the effect this had on Delia:

Repeated texts and calls changed the entire feeling of our morning and [Delia] immediately had to change our plans and she had to get back to him. Although she tried to make it appear normal, the tension was undeniable. Delia was no longer available for the rest of the day and I'm not sure we saw her more than once the rest of that week. Weak excuses for lack of availability were not challenged as I felt I may have gotten her into trouble with Mike and the rest of the family.

Exh. J, p. 1.

Amanda Khozouri and Kathryn Benison had similar experiences when they visited Hawaii. In 2018, Amanda came to Hawaii but "was only 'allowed' to see [Delia] for one day and on Mike Miske's terms." Exh. F, p. 2. She met Delia at Maunalua Bay on a Friday evening, and when they went into the ocean to release flowers for Caleb, she could see Delia "holding back her tears and attempting to force a smile as she said she was fine." *Ibid.* Amanda regrets that she did not question Delia about this, but explains:

[Delia] is not a confrontational person or a person that asks for help because she does not want to be a burden to others. . . . keeping the people she loves most at arms distance was her way of protecting us from the retaliation of Mike Miske.

Exh. F, p. 2.

Others have remarked on how isolated they were from Delia before Mike Miske was arrested. See Exh. E, at p. 3 (Kathryn Benison's access to Delia and N was very restricted before Mike was arrested; one of the Miskes had to be present if she met Delia for a meal, and "it was like they never left her alone."); Exh. C (Liberato Fabro believes Miske "preferred [Delia] to be estranged from [the Fabro] family so they could have more control over her without interference").

In 2019, when Delia's mother was in the final stage of her battle with cancer, Kathryn Benison traveled to Hawaii to be with Lorraine in the hospital. Delia was "permitted" to be at the hospital for the last two days of her mother's life, during which Kathryn witnessed "constant phone calls and checking in by Mike Miske and his family." Exh. E, p. 2.

Delia made all the arrangements for her mother's funeral. Mike Miske stood outside the church and the crematory; he watched, but did not enter. Kathryn Benison writes that she was asked to open the casket, "like he was checking to make sure [Lorraine] was there inside the coffin." After the service, there was a gathering of family and friends, but Delia was only permitted to stay for ten minutes. Exh. E, p. 2.

Delia After Mike Miske's Arrest E.

Mika'ela Pertzoff-Williams writes that after her father was arrested, she "could see [the chains] breaking." Delia's "purpose became solely to her daughter and rebuilding their life on a firm foundation." Mika'ela "admire[s] greatly" "the support [Delia] has found in the church, and the company she keeps. She has found a new family in more ways than one." Exh. H. Kathryn Benison also describes Delia and N as being active in their church. Exh. E, p. 3

Warren Fabro describes Miske's arrest and pretrial incarceration as "a blessing" because

it allowed him to "re-enter into my daughter's life." Exh. B, p. 4. Kathryn Benison writes that Delia has come to understand that Warren Fabro did not abandon her, has always wanted to be a real father to her, and that he is now a strong presence in her life. Exh. E, p. 3.

F. Delia's Relationship with her Daughter N

Bronte Kaneakua describes N as the center of Delia's universe. Delia consistently leaves family parties or gatherings at a reasonable time, to make sure N gets home, showered and in bed to maintain her school schedule. Bronte writes that Delia is "an amazing mother who will always do what is right by her daughter." Exh. G. Warren Fabro also writes that "[N] is everything to Delia, and Delia is everything to my granddaughter. The bond is so apparent and is truly a beautiful thing to behold." Exh. B, p. 3.

Maydeen Stancil, Mike Miske's mother, has written to the Court on Delia's behalf. Ms. Stancil notes that since Mike was arrested in 2020, Delia has provided N with shelter, food, medical, transportation and other living necessities, as well as "a whole lot of love." Note is third School. Delia is focused on her daughter's education: Ms. Stancil says grade at that she enrolls N "in summer school, not summer fun" because she wants her to learn all she can. Ms. Stancil is grateful that Delia makes an effort to involve her in N s life, by inviting her for meals and on outings. Although Ms. Stancil knows that children may be at a disadvantage when one parent is missing, "Delia has stepped up to be the one remaining parent N needs her to be." In concluding, Ms. Stancil writes that "Delia has been there one thousand percent since Caleb's passing to raise her daughter." Exh. G.

G. Delia's Work Experience Since Miske Miske's Arrest

In the summer of 2021, Faith Morse met Delia at International Church. After Faith's son

was born in October 2021, she talked to Delia about the difficulty she was experiencing finding daycare and reasonably priced sitters so she could return to work. She describes Delia's response to her predicament:

Without hesitation Delia offered to help me by watching my infant son while I worked from home. Delia was communicative, punctual, thoughtful and went above and beyond for my son and I. Delia would show up 15 minutes prior to her shift starting, she would wash dishes and clean the house without being asked and beyond her job duties, she would genuinely treat my son as if he were her own anytime she came around. When she could no longer help me after 4 months, she respectfully gave me 2-weeks notice so I could find alternate care. While she couldn't watch him regularly after that, she did continue to watch him and my daughter for a couple evenings when needed.

Exh. L (Faith Morse letter).

Delia stopped working for Faith Morse because she was hired by E Noa Corporation in early July 2022. Her supervisors and co-workers at E Noa speak highly of her work ethic and personal qualities.

Haley Reddell is Director of Operations at E Noa Corporation. She writes that Delia's position as Dispatch Coordinator demands "flexibility, intuition, and a problem-solving mindset." Delia's performance on the job has "exceeded expectations." Ms. Reddell has "collaborated with [Delia] on various projects, witnessing her exceptional work ethic and dedication to her responsibilities." Delia is an "exceptional person . . . at her core."

She consistently brings positivity and joy into any room she enters, cultivating strong relationships and earning the respect of her peers. Delia has demonstrated an unparalleled level of reliability and dependability, qualities that are truly commendable and, unfortunately, rare.

Exh. M (Haley Redell letter).

Lisa Rezentes, one of the Operations Managers at E Noa Corporation, hired Delia as a

dispatcher in July 2022. She writes that Delia's "loving personality . . . brings joy to our coworkers as well as the guests she speaks to over the phone" and that their "staff, from drivers, management, maintenance, cleaning crew just adore Delia" due to her work ethic. Ms. Rezentes is "a very hard worker" and she asks Delia "where can we find more people like you." Delia's E Noa co-workers have become part of her family; she and N stop by on her days off, and "[h]er daughter has a lot of aunties and uncles here that's for sure." Exh. N.

Reynold Lani Dayton, Jr., is the Operations Manager and Transportation Manager for E Noa Corporation. Delia joined E Noa to work as Dispatcher for the Airport Division, a new venture for the company. She was responsible for arranging all pickups and drops for guests arriving and departing different hotels in Waikiki, and Mr. Dayton has worked closely with her. Delia "has excelled in our daily work commitments." He Delia as "a nice, caring, respectful, and humbled person." Delia has also become a valued friend of his family. Mr. Dayton writes that "Delia and Na are my OHANA, there is nothing I won't do for either of them." Exh. O.

KC Arakaki-Mineshima is Delia's co-worker at E Noa Corporation. She "is not only responsible but goes above and beyond in fulfilling her duties and commitments." Delia "excels in providing a nurturing and stable environment for her daughter." She is also "actively engaged in community service and volunteer work," "an active member of her church community," and "her dedication to making a positive impact on the lives of others reflects her compassionate nature and a genuine desire to contribute to the well-being of the community." Exh. P (KC Arakaki-Mineshima letter).

Samantha Meno, who works in the media/advertising at E Noa, describes Delia as "a person of exceptional qualities who has made valuable contributions to our workplace . . . she is

not only an asset to our team but also has a positive influence on those around her." In addition, Delia is also "a great friend and an incredible mom." Exh. Q (Samantha Meno letter).

H. Pleas from Delia's Family about Sentencing

Amanda Khozouri poses, and answers, a question that the Court may very well have:

The obvious question is why didn't [Delia] leave or do anything to inform authorities? If Ms. Fabro-Miske is the good, loving, kind, and resilient person I just described, why are you here reading this character letter? Because we are talking about a traumatized individual who was in shock after losing her husband, navigating life with a newborn baby while also processing the complicated emotions related to her mother dying in 2019 without closure. Ms. Fabro-Miske defaulted to survival mode, compartmentalizing because she still wanted to show her daughter the softness she deserved, while fearing the consequences for both of them.

. . . Ms. Fabro-Miske was a teenager walking into a lion's den and is now strong enough to leave. . . .

I pray that you allow her the opportunity to raise her daughter and show others all she has to offer. I am extremely appreciative to you for allowing me the opportunity to speak on Ms. Fabro-Miske's behalf and it is my hope that the information provided will be helpful when the court is considering what true justice looks like in this case.

Exh. F, p. 2.

Kathryn Benison "respectfully ask[s] your Honor to find leniency in your heart," to not leave N without either parent, and to give Delia "the opportunity to have a life with her daughter away from the watchful eye of Mike Miske." Exh. E, p. 3.

Mika'ela Pertzoff-Williams prays for "grace and mercy, not just for [Delia] but for her sweet daughter, who has already lost her father, and will soon be losing her mother." he writes: "I pray for understanding and compassion for Delia. . . . Above all, I pray the Lord gives you the wisdom and strength in this decision, and future decisions, you have to make. Exh. H.

Emily Khozouri implores the Court to allow Delia and N to stay together. Exh. J, p.

2. Warren Fabro asks that the Court "give my daughter a second chance" which would also "give me a second chance to be the father that I should have been and continue to be a guiding force and provide support for my daughter and granddaughter." Exh. B, p. 4. *See also* Exh. A (Liberato Fabro writes that Delia's "prolonged absence from N 's life would be devastating for her and would be incredibly difficult to overcome").

II. Adjustment for Acceptance of Responsibility

The Draft Presentence Investigation Report ("PSR") filed November 26, 2024, states the following under the heading "Adjustment for Acceptance of Responsibility:"

On 10/21/24, the defendant was interviewed in the presence of defense counsel at the US Probation and Pretrial Services Office. She accepted responsibility for committing the instant offense and expressed remorse for engaging in criminal activity. She believes she would not have committed the offense if confronted with the same situation today.

Doc. 1776, p. 25 ¶ 54.

The Revised PSR filed April 2, 2025, includes the following statement under the heading "Justification:"

... [A]s noted in her Sentencing Statement, the defendant contests her involvement in a significant number of the RA s asserted by cooperating defendants, including more than half of the RA s attributable for her for guideline computation purposes in this case. As a result, the defendant has minimized her conduct and has not fully accepted responsibility for her involvement in the instant offense. . . . Of further concern, the defendant has articulated no remorse for her participation in the kidnapping or murder of Fraser. Instead, she has put the blame entirely on Miske. The aggravating factors in this case increase the defendant's likelihood of recidivism and risk of danger to the community.

Doc. 1881, pp. 46-47.

The discussion of Ms. Fabro-Miske's acceptance of responsibility in the Draft PSR is clearly at odds with that in the Revised PSR. The only intervening factor between these two very different descriptions of Ms. Fabro-Miske's state of mind is her Sentencing Statement, filed under seal on March 14, 2025. In that document, counsel for Ms. Fabro-Miske objected to the Draft PSR's consideration of Racketeering Acts 1 and 2 as relevant conduct under USSG § 1B1.3. *See* Sentencing Statement, pp. 2-15. This was a legal argument by counsel that the kidnapping and murder of Jonathan Fraser should not be considered relevant conduct, based on facts adduced at trial, USSG § 1B1.3, and case law interpreting § 1B1.3. However this is a legal argument, not an expression of Ms. Fabro-Miske's state of mind.

In *United States v. Rojas-Flores*, 384 F. 3d 775, 781 (9th Cir. 2004), the defendant challenged the applicability of 18 U.S.C. § 1791 at a bench trial and was denied a reduction for acceptance of responsibility. The Ninth Circuit held that the defendant did not challenge the underlying facts, but only their legal interpretation, and was not precluded from a reduction for acceptance of responsibility because "the perceived strength of [the defendant's] legal argument does not transform [the] argument from a legal argument to a factual dispute." *See also United States v. Fells*, 78 F. 3d 168, 171-72 (5th Cir. 1996), which is cited in *Rojas-Flores*. In *Fells*, the defendant went to trial and argued that the underlying facts did not legally constitute "possession" within the Northern District of Texas. He was convicted and at sentencing was denied an acceptance of responsibility reduction. The Court held that the defendant's challenge to venue at trial was not a denial of the underlying facts and did not preclude a reduction in sentence for acceptance of responsibility. *Id. See also United States v. Ochoa-Gaytan*, 265 F. 3d 837, 844-45 (9th Cir. 2001) (denial of acceptance of responsibility reduction because

defendant did not plead guilty and moved to suppress his custodial statements was error).

In *United States v. McKinney*, 15 F. 3d 849, 853 (9th Cir. 1994), the Court stated that a "focus on the defendant's personal contrition, rather than the exercise of his constitutional rights, best serves the purposes of the acceptance of responsibility reduction." Ms. Fabro-Miske is genuinely contrite, as the Draft PSR found. The Sentencing Statement's legal objections to the consideration of the Jonathan Fraser offenses do not diminish her contrition and ought not be considered as such.

The PSR will affect Ms. Fabro-Miske's life for years. It now includes statements about her "minimin[ing] her conduct, "not fully accept[ing] her responsibility for her involvement," and the resultant "likelihood of recidivism and risk of danger to the community." Doc. 1881, pp. 47048. These statements are not based on anything Ms. Fabro-Miske has said or done, but on legal arguments raised by counsel. It is respectfully requested that the Court order the preparation of a revised probation report that omits any reference to minimization, failure to accept responsibility, and likelihood of recidivism and risk of danger to the community. *Cf. United States v. Herrera-Figueroa*, 918 F. 2d 1430, 1437 (9th Cir. 1990) (where defendant refused a probation interview because counsel was not present, there was no information on his acceptance of responsibility and the resulting sentence was based on incomplete information; on remand, defendant was entitled to a new presentence interview and sentencing hearing).

III. Conclusion

Based on the foregoing, and on the previously filed Sentencing Memorandum, it is respectfully requested that the Court order the preparation of a revised probation report that does not penalize Ms. Fabro-Miske for her counsel's legal arguments. Further, for the reasons set

forth in the Sentencing Statement and this Sentencing Memorandum, it is respectfully requested that the Court impose a non-custodial sentence on Ms. Fabro-Miske.



I am writing this character reference letter in support of my niece, Delia Fabro-Miske. My name is Kathryn Benison. I am the sister of Delia's late mother Lorraine Benison. I have known Delia her entire life. As a young child, she was gentle, kind, loving, caring, and eager to please. Even though I've always lived in New York, and she grew up in Hawaii, we managed to speak with each other frequently and she visited New York almost every year for weeks at a time. My children and Delia have always been close. Delia was expected to be older than her age because at times she was required to be the adult in her household. I wanted to provide some background for the court.

Delia did not have a typical childhood as my sister was mentally ill. My sister had two sides, on the one hand, she was intelligent, entertaining, funny, witty, charismatic and generous to a fault with her time and talents. Alternately, she could be cruel, controlling, mentally, verbally, and physically abusive to her children. Delia was not permitted to have an opinion ever. Delia was emotionally and ultimately physically separated from her father when her parents divorced. My sister used extreme emotional manipulation with her children and turn them against their father. She wanted her new husband to be called dad and Warren was to be called by the initials DW or daddy Warren. Warren was an excellent father even after the divorce and every day made the children's lunches, cleaned their uniforms, did their laundry and took them to school. Once my sister remarried, Warren was shut out and not permitted to have regular interaction with the children.

Delia was responsible for cooking and cleaning and taking care of her younger siblings. My sister worked infrequently, and money was very tight for the family as my sister's new husband was a guitar player and taught music at their school for free tuition. This hardly was enough to cover any of their expenses. Delia and her sister Caleigh were taught Irish dancing, and Irish music by their mom, and at times, danced in the streets of Honolulu for money for food for their family. Objecting to my sister's wishes was never permitted. Delia and Caleigh danced in the streets until they were in their teens along with their brothers. To shed light further light on how they lived, Delia's mom kept a stick above the door she called it the law. If you

broke her laws, the law broke you. When food was short, the children were told they were fasting for whatever sins she could think of. It is my belief that being raised in this type of situation set the stage for why Delia never questioned and was obedient to Mike Miske. She met Caleb Miske as a teenager, and he swept her off her feet. He was a nice boy. And they loved each other. Delia became pregnant and they were married. A few months later, Caleb was in a terrible car accident that left him in the hospital for months. Their daughter, N born during this time. Fortunately, he did get to hold her before he passed away. During this time, my sister had a reoccurrence of breast cancer. Mike Miske shared in Delia's grief with the loss of his son and quickly embraced, Delia and N This would prove to be Delia's greatest undoing. She was a young mom, who was widowed with a baby (who was She was grieving and heartbroken, alone with nowhere else to turn and no money. She felt fortunate that he let her work in his office and help take care of the baby. Things quickly turned as he took control over her life, and she was no longer permitted to see people other than him and his family. Delia was numb and operating in a state of depression, grief, and simply overwhelmed. When No, her daughter was less than one years old, she came to New York with her mother to see us and meet up with Mike Miske's daughter, who attended college on the East Coast. Delia, being a churchgoing person who attended Catholic schools decided to have baby N a baptized when she was here in New York. My daughter was her godmother. When Mike Miske heard about this, he kept Face Timing Delia and told her she had to come home. He didn't understand that it was a religious ceremony. I believe that he thought that my daughter now had some control over the baby, and this infuriated him. Delia worked in the office into the evenings most days which limited her access to her daughter. He was in control and Delia followed orders. All the while, she was being isolated from her paternal family. The only time my sister could see Delia and N was down by Maunalua Bay where Mike Miske's family would meet every Friday night to lay a wreath in the water for Caleb. This went on for years after his death.

When my sister was dying, I came to Hawaii to be with her in the hospital. The last two days she was alive, Delia was permitted to be at the hospital, and she was a caretaker to her mom. I was a witness to the constant phone calls and checking in by Mike Miske and his family. When my sister passed it was Delia and I in the hospital room waiting for the morgue to come take her body. Delia was stoic. She immediately helped me make all the arrangements for the flowers, phone calls, the Church, and the funeral. She made sure her brothers had suits and clothing to wear. She made the programs for the service. At the Church on the day of my sister's funeral, Delia gave the eulogy. Mike Miske stood outside the church. He didn't come in. The same for at the crematory. However, he did have his girlfriend ask me to open the casket. I thought it was a very odd request because I knew nothing of what was going on behind the scenes. It was like he was checking to make sure she was there inside the coffin. There was a gathering after the service, and Delia was only permitted to stay 10 minutes.

However, Delia's father Warren was always in the background, always a staple waiting to assist his children. Since the death of my sister and the incarceration of Mike Miske the relationship between Delia, Warren, and N has grown to be a loving and supportive relationship with Delia understanding that he has always been a part of her life and always was willing to support her. I have returned to Hawaii each year since my sister has passed to see my nieces and nephews and we have remained close. I would get updated pictures of Delia and N and phone calls on my birthday and Christmas and if something sweet was going on with N However, when I would come to Hawaii, my access to them was very restricted if she came to meet me for a meal one of the Miskes had to be there, it was like they never left her alone. She remained kind and gentle and caring. She is so good with N Once Mike Miske went to jail, when I visit Hawaii Delia and N spent days and nights with me at my hotel. I stayed at her apartment. I had unlimited access to both of them. Her father Warren had a dinner at his home for all of his children and myself and this could not really be a coincidence since both my sister was gone and Mike Miske had gone to jail.

Delia has secured full-time work has an apartment and takes very good care of N. She is hard-working, kind, dependable, and strong. Her fractured relationship with her father has been healed and he is a source of strength. Both N and Delia are active in their church. Delia was controlled and manipulated by somebody that I believe she may have feared. I think he took control of her daughter, and if she wanted access to her daughter, she had to do what he said. I have remained in touch with Delia throughout this time. She has remained loving and warm and kind. My niece was not free to make decisions for herself as she being controlled by a master manipulator. From what I can see he is a dangerous person as well.

I respectfully ask your Honor that you find leniency in your heart. Please do not take her from her daughter leaving her daughter with neither parent. Please give Delia a second change and the opportunity to have a life with her daughter away from the watchful eye of the Mike Miske.

My name is Amanda Khozouri, Psy.D. and I am writing on behalf of my cousin and friend, Delia Fabro-Miske, to share with you who she was, is, and could be. We cannot choose our family, but I would choose Ms. Fabro-Miske in every lifetime. Like much of the public, I have read every article and followed every story where her name was listed. To say that I have felt heartbreak, anger, defensive, confused, and protective is an understatement. Not one article or news story can tell you who she is or how she got here, but I strongly believe I know Ms. Fabro-Miske at her core. I believe this because I have been there for every phase of her life.

Ms. Fabro-Miske is not perfect, and I am not justifying or excusing behavior or actions. However, it is vital to explain how the carefree, gentle, naïve, and adventure seeking girl turned into being a survivor. I have spent my 20s earning a Doctorate degree in Clinical Psychology and I understood Ms. Fabro-Miske on a deeper level the more I studied the negative impacts of trauma. Ms. Fabro-Miske has been living in survival mode for most of her life, and she coped through compartmentalizing. Ms. Fabro-Miske lived in a home where children were to be seen and not heard. She was molded to do as she's told without asking why otherwise she suffered the physical consequences. While Ms. Fabro-Miske's mother was a remarkable and whimsical aunt, she was an uncontrollable and unpredictable mother due to untreated mental health issues. Ms. Fabro-Miske may be petite, but to me she is as strong as a giant and resilient has titanium. Despite these hardships, she remained soft and sought kindness in others. She survives. Ms. Fabro-Miske is not a malicious, vengeful, or a manipulative person. She was looking for the light when she met Caleb Miske.

It's important to know that when Ms. Fabro-Miske loves, she loves fully and selflessly. As a teenager, she saw the future with Caleb Miske in the way a little girl waits for prince charming, and he quickly became her **everything.** Along with Caleb Miske, came his father whose predatorial eye saw Ms. Fabro-Miske as someone he could manipulate, groom, and intimidate. When my goddaughter, N Miske, came into this world, Ms. Fabro-Miske was staring at her husband in a hospital bed and processing her complicated relationship with her mother as she battled cancer. Once again, Ms. Fabro-Miske showed the world who she was and remained focused on all the light and love she could pour into her little girl. This is when Ms. Fabro-Miske was slowly pulled from her family and isolated.

When your world is crumbling, all you are trying to do is breathe and you miss the red flags of being abused. The light from her eyes dimmed when Caleb Miske ultimately died of his injuries. Every day was a funeral and Ms. Fabro-Miske was seen as a pawn Mike Miske could use to replace his son and, ultimately, control Ms. Fabro-Miske and her newborn. What she thought was a loving gesture from her father-in-law, became her ball and chain. In 2016, my cousin and goddaughter flew to New York to have N baptized. This is when I observed Ms. Fabro-Miske operate out of fear, the same way she had as a child. The phone didn't finish the first ring before she answered the dozen calls that came daily from Mike Miske. He tracked her every move, threatening her that this would be the last time she would travel with her own daughter to see her family.

When I would call to speak to Ms. Fabro-Miske, it would be 5-10 minutes into the call that I would realize someone else was holding the phone and listening to the conversation. This was constant. In 2018, I flew to Hawaii and was only "allowed" to see Ms. Fabro-Miske for one day and on Mike Miske's terms. We went out into the water to release flowers in honor of Caleb, and this is the moment I regret to this day. I could see my cousin holding back her tears and attempting to force a smile as she said she was fine. I should have pushed the topic harder and listened to my gut, but I didn't. Ms. Fabro-Miske is not a confrontational person or a person that asks for help because she does not want to be a burden to others. In fact, Ms. Fabro-Miske keeping the people she loves most at arms distance was her way of protecting us from the retaliation of Mike Miske.

The obvious question is why didn't she leave or do anything to inform authorities? If Ms. Fabro-Miske is a the good, loving, kind, and resilient person I just described, why are you here reading this character letter? Because we are talking about a traumatized individual who was in shock after losing her husband and navigating life with a newborn baby while also processing the complicated emotions related to her mother dying in 2019 without closure. Ms. Fabro-Miske defaulted to survival mode, compartmentalizing because she still wanted to show her daughter the softness she deserved, while fearing the consequences for both of them.

Ms. Fabro-Miske is a fighter and a person who is owning up for her mistakes. Her bravery is embedded in her actions to finally stand up against the person who has kept her as a physical and emotional hostage. In between birthdays and events that either her family or my family is hosting, we keep in contact by either texting or calling each other to catch up or setting aside a little date day with my little family and hers.

I have gotten to see and know Delia while her and my brother were together, and after, which in this case, has been heartbreaking. Understandably, there was a personality shift after she had lost her husband. Their baby was only a couple months old when Delia had to become a single mother, while enduring the loss of her love. To advise her to separate herself from that family, is a lot easier said than done and, if I'm speaking candidly, I believe was a dangerous but essential choice. However, I recognize that she chose to remain a part of that family, and I know she regrets the degree in which she was.

After Mike Miske's arrest, chains were still attached, but I could see them breaking. Her purpose became solely to her daughter and rebuilding their life on a firm foundation. She's worked to find a good job that could sustain herself and her daughter and has taken all the steps needed to detach herself from anything that does not build her daughter and her future up. What I admire greatly is the support she has found in the church, and the company she keeps. She has found a new family in more ways than one.

The person Delia is today is almost unrecognizable to the person she was in 2020. I know in my heart that Delia is not only willing but longing to live a constructive life that can be an example for her daughter. God is good for allowing her to have the time that she's had with her daughter. Now that a large part of her future is in your hands, Judge Watson, I again plead for grace. I pray for grace and mercy, not just for her, but for her sweet daughter, who has already lost her father, and will soon be losing her mother. I pray for understanding and compassion for Delia; I pray that you may see the potential she has to be outstanding. Above all, I pray the Lord gives you the wisdom and strength in this decision, and future decisions, you have to make.



My name is Emily Khozouri, and I am writing this character reference in support of my cousin, Delia Fabro-Miske. Though we live so far apart, I have loved Delia since I was a child and have known her my entire life. Some of my happiest memories from childhood are from the weeks Delia would come visit New York in the summers and stay in our grandmother's house with us. Our house is small, so the sleepovers often meant us huddled on air mattresses in the living room, but that didn't matter. All that mattered was that we were together.

When we were younger, the five-year age gap felt so much bigger. I'd get to brag that my cool older cousin from Hawaii was visiting as she sat through various graduation and awards ceremonies, even though she could've spent her time doing something more entertaining in New York. We'd spend hours just watching old movies, her favorite YouTubers or musicians that she wanted me to know. As the younger cousin, I had to be "cultured." My relationship with Delia wasn't one of constant communication but we always picked up right where we left off whenever we got to see each other again.

In her teens, Delia stopped visiting New York for weeks in the summer. It had been a few years since we'd been together in person before she brought N to New York shortly after Caleb's tragic death. I don't have the words to explain how strong and resilient Delia is. I can't imagine how difficult it was being a single mother and a widow at her age due to unimaginable circumstances. However, it is fitting that

has been the light of Delia's life. Despite all the hardship, N has always been Delia's priority above all else. When I'd have a chance to speak with Delia, even a simple "How are you? Any good plans coming up?" always turned into an update on N No one could come close to the way Delia matched N energy. Never had to sing alone in the car through her Frozen phase and was supported through all her fascinations of the month. Aside from the fun, Delia would reach out to my sister who is a psychologist most to find the best ways to address N as questions. It's increasingly difficult to answer, "Where's daddy?" considering everything going on.

I love Delia wholeheartedly and I'd be doing her a disservice if I didn't acknowledge how our dynamic changed the more time she spent with the Miske family. Although I didn't recognize it in the moment, Delia's visits stopped around when she and Caleb became more serious. The first time I visited Hawaii along with my mom, we couldn't see Delia without someone from the Miske family present, whether that be Andy, her sons, or Mike himself. Car rides would be interrupted by phone calls asking for estimated time of arrival and where exactly we were if we weren't directly in their line of sight. It's difficult to try to push away the obvious way they were isolating her from her family, even us.

I'll never forget the day we decided to take a sunrise hike and swim. We left our phones in the car so they wouldn't get wet. We were without our devices for maybe an hour, but by the time we came back Mike and his family had reached out multiple times. Repeated calls and texts changed the entire feeling of our morning and she immediately had to change our plans and she had to get back to him. Although she tried to make it appear normal, the tension was undeniable. Delia was no longer available for the rest of the day and I'm not sure we saw her more than once the rest of that week. Weak excuses for lack of availability were not challenged as I felt I may have gotten her into trouble with Mike and the rest of the family.

The second time we visited, this changed as Mike had been indicted and arrested. We finally had a chance to see Delia without the feeling of being watched. She and N slept over in our hotel and Delia and I even had a chance to go out to dinner and grab a drink without anyone else. It felt like when I was a child again. We talked about whatever new movie was out that we were dying to see and N obsession with How to Train Your Dragon. I didn't ask about updates or the trial because I wanted one night where the Miske family didn't take over. The ability to laugh over nothing and run from store to store to pick up late-night ice cream and mochi let me pretend it was a variation on the summers in New York. All that mattered was spending time together again.

I acknowledge that Delia has pled guilty for conspiring to bank and wire fraud and obstructing justice. I will not pretend that I know for certain everything that is going through Delia's head or what choices informed her decisions. However, I can't wrap my head around how she could not be scared with how involved Mike and his family had been in her life. Who would willingly put up with the kind of tracking and surveillance they had on her? Moreover, who wouldn't be scared after all that has come out about Mike's influence. I believe she remained tied with the family because of the losses of Caleb and my aunt Lori. Since she was born, N mas been exposed to loss in all forms. I assume Delia is trying to keep up as much normalcy as possible and not isolate N from her family as she had been isolated from her own.

I ask that you find leniency for Delia, and more importantly N worry what will happen if she were to lose both parents. Despite the chaos that has ensued, N has always had Delia as her rock. Delia is an amazing, doting, and loving mom and never allows the darkness surrounding this situation to reach N do not believe her involvement was anything more than a means to protect her daughter. Please allow her family to stay together.

I have continued to be in both her and my great granddaughter Nila's life, I continue to help watch whenever Delia needs me to.


