THE FOLLOWING YEAR, JULY 1988, MR. S [REDACTED] CONTACTED THE DHS REQUESTING FOSTER PLACEMENT FOR THE BOYS STATING THAT HIS WIFE HAD "DUMPED THEM ON HIM LAST YEAR AND HE WAS TOO STRESSED OUT TO DEAL WITH THEM APPROPRIATELY. J [REDACTED] AND HIS BROTHER, A [REDACTED] WERE PLACED IN AN EMERGENCY SHELTER HOME. AFTER 16 DAYS, J [REDACTED] WAS PLACED WITH HIS PATERNAL AUNT, N [REDACTED] S [REDACTED] FROM 7/27/88 TO 4/15/91. A [REDACTED] REMAINED WITH MR. S [REDACTED] SR. AS HE FELT THAT HE COULD CARE FOR ONE CHILD. FROM 4/15/91 TO 4/24/91 MRS. S [REDACTED] PLACED J [REDACTED] WITH HIS MOTHER D [REDACTED] (B [REDACTED] C [REDACTED] BECAUSE MRS. S [REDACTED] AND HER HUSBAND WERE GETTING A DIVORCED AND THEY COULD NO LONGER CARE FOR HIM. FROM 4/24/91 TO 8/12/93 J [REDACTED] RESIDED WITH P [REDACTED] AND B [REDACTED] D [REDACTED] WHERE A [REDACTED] RESIDES PRESENTLY.

THE GOAL OF ADOPTION WAS CHANGED AFTER SOME DISRUPTION OCCURRED IN THE D [REDACTED]'S HOME. J [REDACTED] WOULD CONSTANLY TEASE AND HARASS HIS BROTHER. HE ALSO HAD DIFFICULTY COMMUNICATING AND COOPERATING WITH THE FAMILY WHICH LED TO THE REMOVAL OF J [REDACTED] FROM THE HOME.

J [REDACTED] CURRENTLY RESIDES IN THE HOME OF MR. J [REDACTED] T [REDACTED], FOSTER FATHER. ACCORDING TO MR. T [REDACTED], J [REDACTED] IS DOING OKAY IN THE HOME. J [REDACTED] SEES DR. ARTHUR WALKER FOR THERAPY EVERY TWO WEEKS. HE USUALLY CATCHES THE BUS TO AND FROM THERAPY. DR. WALKER IS CURRENTLY ADDRESSING INTERPERSONAL PROBLEMS, INAPPROPRIATE TEASING, AND ADJUSTMENT WITH J [REDACTED]
