This letter is to inform you of the outcome of the complaint on March 20, 2003: alleged sexual abuse of 14-year-old N. M. and alleged threat of sexual abuse to R. M. (age 10); K. M. (age 15); A. M. (age 10); F. K. (age 11) by their foster father, Mr. Teixeira.

The investigator's report dated May 12, 2003 stated that the "allegations of sexual abuse and threat of abuse are unsubstantiated. There was no disclosure of harm by the alleged victim and no disclosure of witnessed harm by any of the foster children, past and present."
