KAULANA FREITAS' SENTENCING MEMORANDUM AND REQUEST
SEEKING DOWNWARD VARIANCE

Thirty six year old, KAULANA FREITAS, faces sentencing for Count 1:
Racketeering Conspiracy, 18 U.S.C. § 1962(d) and Count 13: Use of Chemical
Weapon 18 USC §§ 229(a)(1) and 229(a)(2) and 229A(a)(1).

There is a Memorandum of Plea Agreement in this case. Based upon the plea agreement, Defendant requests a 1-level reduction in the offense level under USSG §E1.1(b). Furthermore, given Defendant's acceptance of responsibility, Kaulana requests a 2 level decrease pursuant to USSG§E1.1(a). These requested reductions are verified as indicated in the PSR, ¶¶92 & 93, pages 29 & 30. [REDACTED]

Furthermore, KAULANA requests that this Honorable Court vary below the advisory guideline range and the requested downward departure sought by the government based on the value of his cooperation and 8 U.S.C. §3553(a) factors that are further discussed in this memorandum. Mr. Freitas' sentence should effectively be reduced to level 15, which is consistent with the amount of time he has already served of 18 months. He would still be on Supervised Release and under the jurisdiction of the Court for further monitoring and additional sanctions if deemed appropriate at that time. Certainly high fines, community service and house arrest at the disposal of the Court.

I. Kaulana's History and Characteristics and the Facts and Circumstance of the Offense Also Support a Significant Downward Variance

a. Defendant's Remorse and Acceptance of Responsibility.

Mr. Freitas pled guilty and cooperated with law enforcement. Per the presentence report, he accepts responsibility for his actions. See PSR at ¶46. Furthermore, Mr. Freitas statement to the probation officer reflects his remorse and acknowledgement of the wrongfulness of his conduct . It is further anticipated that he will address the court to express his acceptance of responsibility and regret for his role in this case.

b. KAULANA has a positive, supportive and loving relationship with friends and family.

The defendant's family and friends remain extremely supportive. See Exhibit "A" - "I" As per the presentence report, his father [REDACTED] and mother [REDACTED] have been supportive and positive influences for Kaulana. They remain in close contact. Their testimony is reflected in Exhibits "A" and "B." One or the both of them are expected to be present in court to support their son. They verify that the family is supportive of Kaulana which will assist him re-integrate back into the community. His older brother, [REDACTED] has verified Kaulana's background, difficulties in life and the reasons for his involvement with his cousin Michael Miske. However, [REDACTED] also reaffirmed Kaulana's commitment to a prosocial, crime-free

lifestyle and he further attests that he does not believe that Kaulana would reoffend. See ¶111 and Exhibit “C.” Kaulana’s brother [REDACTED] also confirms his support and further echoes his positive efforts in rebuilding his life. See Exhibit “D.”

Both his sons [REDACTED] (17) and [REDACTED] (15) have a deep and close with their father. See Exhibit “E” and Exhibit “F.” Kaulana remains active and firmly committed in the lives of with his children, and now newly born grandson. Kaulana’s new girlfriend [REDACTED] has been an encouraging force in his life and continues to inspire his prosocial lifestyle. See Exhibit “G.” These relationships provides him with the added incentive to maintain a clean, sober and law-abiding lifestyle.

Mr. Freitas had a difficult emotional time when his parents separated. That perhaps influence some of the wrong choices he made in his youth. He now reflects back upon his past choices and wants to be there for his children, and his girlfriend’s children and now new grandson. Kaulana wants better for them, which can only be achieved by him continuing his current path and being by their side. He thrives to be a good role model and to teach them to avoid bad choices and support them through life’s struggles.

c. Kaulana has led a law-abiding lifestyle since his release from custody

Defendant was released on or about January 22, 2024. Since his release from custody, he has abided by the terms and conditions of this Court. He took advantage

of that opportunity after the Court warned him. He took this opportunity to heart. Since then he has left the life of crime and has never looked back. He has not been in any kind of trouble since his release

He has managed to be gainfully employed. He has surrounded himself with positive life influences. He primarily works and spends time with his family, law abiding friends, including a new girlfriend and her family.

He has been successful while on pretrial release. This evidence his ability to live a law abiding lifestyle. He has led a clean and sober lifestyle. For three years, he has tested negative in his drug tests. He has checked in and has followed the instructions of his pretrial officer.

Mr. Freitas has consistently demonstrated his ability to live a normal life. Kaulana was on an ankle bracelet for 2 years and 8 months. He was finally allowed to remove that bracelet and he continues to comply with his pretrial release conditions. He originally stayed with his father and finally became able to live independently and support himself. With each opportunity of trust, he did not disappoint.

d. Mr. Freitas has been gainfully employed.

Mr. Freitas returned to the union and was able to be employed throughout most of his release. Kaulana currently works for BK Construction full time. Others who know him from work and as a professional describe his hard work, strong work ethic and reliable team player. See Exhibit “J”

While on release he was given permission and an opportunity to travel to the neighbor islands. He has always returned without incident. In the past, he has a consistent job history See ¶¶ 121-126. His future plans are to eventually open his own plumbing company or take over his father’s company. See ¶ 127

e. Further incarceration would entail severe hardship for the family.

Mr. Freitas has children that depend on him for support. He is the lifeline for the family. He has two boys ages 17 and 15 years old. The 15 year old, [REDACTED] just recently became a father. It is likely that as a new grandfather with a young son, he will be even more needed for his guidance as well as emotional and physical needs. Given his support of his girlfriend and her children, they would be impacted as well if he is now sent back to prison.

f. Kaulana is not a danger to the community.

Kaulana has changed his life and put his old life behind him. He has stayed away from dangerous, negative “friends” and influences in his life. He is not someone that needs to be incarcerated for the protection of the community.

While he has been out of custody, he has shown that he is law-abiding. Kaulana no prior convictions and he has no subsequent trouble after his release. This was his first time in locked up. That was enough for him to get the message, and he has stayed true to living a prosocial lifestyle.

g. Kaulana can respond well to a program of rehabilitation, which does not support further incarceration.

He has been on pretrial release for a substantial period of time. During such time, he has had no issues or problems. It is worth repeating, he has led a pro-social lifestyle. He has been checking in and following all rules. The 18 months he had served is sufficient to modify his behavior. From this perspective, Kaulana is not a danger to the community who must be further incarcerated, either for punishment or for the protection of the public.

h. Kaulana has managed to educate and improve himself while in detention and after his release

Despite Kaulana's lockdown status at the Honolulu Federal Detention Center, he participated in a number of programs. Although he was in his cell for most of the day, he participated in bible studies, substance abuse education, anger management courses, and educational type classes through the Quantum Units Program. He earned a number of certificates and documents that verify his efforts. See Exhibit "K." Even after his release, he has been working toward obtaining his GED. He is hoping to obtain his certificate by the time he is sentenced before the Court.

k. When factoring in COVID's solitary confinement, Kaulana's imprisonment is equivalent to more than the 18 months he has served.

Kaulana experienced COVID lockdown for a majority of his time at the FDC. During the height of COVID, time detainees were locked down in isolation in their cells for over 23 hours. Mr. Freitas' experience was like being in the Special Holding Unit, but arguably worse. In the beginning they were allowed to come out of their cells and make phone calls for only 15 minutes per a day. Some days, they were not allowed to even make a phone call. During the COVID lockdown, inmates were allowed to shower only every three days. Later, the time out of their cells expanded to one hour outside of their cell. Even then, sometimes they were not allowed to even use the phones to call loved ones or to even participate in recreation. For Kaulana, this lockdown experience lasted for over a year, approximately 14 – 15 months. Mr. Freitas custody circumstances slowly normalized between months 15 and 18.

These unusually severe conditions—arising from an unprecedented situation over which no one has had any control-- warrant a reduction of time from Kaulana's sentence. This is a reasonable accommodation to account for the increased severity of the conditions under which Kaulana lived for over one year. *See, United States v. Spano*, 476 F.3d 476 (7th Cir. 2007) (recognizing that the argument that “a prison sentence has two dimensions: its length, and the harshness of the conditions, and that the harsher the conditions the shorter the sentence

should be” has “enough merit to . . . allow a sentencing judge to take it into account, *Koon v. United States*, 518 U.S. 81, 111-12, 116 S. Ct. 2035(1996)[.]”); *cf. United States v. MacFarlane*, 438 F.Supp.3d 125, 127 (D. Mass. 2020) (granting in part defendant’s motion to reduce sentence, the court “determine[d] that Macfarlane’s two-week confinement in solitary quarantine in a higher security facility is the equivalent of two months in the Camp to which he was originally assigned.”). The Court is therefore authorized to reduce or determine a sentence to account for these conditions. Kaulana respectfully requests that this Court exercise its discretion to factor his incarceration during COVID into consideration. Because of the additional and unusual circumstance that Mr. Frietas endured, a further downward departure is warranted.

II. Conclusion

There are a number of reasons why the Court should grant a downward variance in Kaulana’s particular circumstance and impose a sentence of credit for time already served.

[REDACTED], his offense level should be reduced to level 15. He has already served 18 months, which is level 15. His time in COVID isolation and conditions should be factored in. Alternatives to jail, such as further home detention, higher fines and community service are options for the Court. Even

if the Court sentences him to time served, the threat of jail still remains on Supervised Release.

Kaulana was not the leader or organizer of the Miske Enterprise (“ME”). Rather he was primarily a follower. Unlike others, he was not involved of any Kidnapping or more serious matters. Unfortunately, he took his cue and direction from others, particularly from his cousin Mr. Miske. For Kaulana’s actions, he has expressed deep remorse for his involvement in this case. He is being sentenced for his involvement in the ME that occurred approximately between 2014 and 2018. Kaulana was in his 20s back then. Kaulana has now forsaken his criminal past and has moved forward in a positive direction. He has already put his prior lifestyle behind him and is leading a law abiding lifestyle of the past nearly three years. He has transformed himself and rebuilt his life from the bottom up. He now supports himself the legal way, and is able to support his children and assists with his girlfriend’s children and kids financially and emotionally. Fortunately, with the opportunity that this Court provided him, and with the help of his immediate family, has made good use of his time. He has abided by the terms and conditions of release. He has dealt with his addictions through long term abstinence and education. He has tested negative for the last 3 years. In truth, it does not make sense for the community to return the Kaulana of today back to jail at this point in time. In fact, the record allows us to argue that it is foreseeable that Kaulana would not return to a

life of crime and that he has learned his lesson.

The factors under 18 U.S.C. 3553 (a) allow for a significant departure balancing the factors in this case. Without conflating the factors under 18 U.S.C. 3553 (a), [REDACTED]

Kaulana has no prior convictions. He has acknowledged his wrongdoing and accepts full responsibility for his misconducts. He continues to have the support of his family and has loving relationships. Kaulana has fully learned from his time in custody and did not let this Court down when it allowed the conditions for his release. It would not help anyone, much less the community, to now to rip him from his current path and send him back to where we know criminal elements reside.

Kaulana did not let the Court down all this time. He is on track to not let this Court down in the future. Applying the factors in §3553(a) discussed above, [REDACTED] [REDACTED] along with extraordinary COVID conditions during his time incarcerated, on balance, the sentence of 18 months is sufficient and is not greater than necessary to achieve the goals of sentencing.

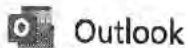
As a father, I humbly ask for your compassion and understanding as you deliberate on his case.
