WARRANT OF ARREST

To the Sheriff and any state law enforcement officers of the State of Hawaii or the Sheriffs First Deputy; any law enforcement officer in any county or city and county of the State of Hawaii; and any law enforcement officer in any state of the United States; Execution of the warrant between 10:00p.m. and 7:00a.m. on premises not open to the public is prohibited.

GREETINGS: You are hereby directed forthwith to arrest and take the body of the above-named, a paroled prisoner, accused of violation of the terms of parole, if found and return as soon as possible to the custody of the Director, Department of Corrections and Rehabilitation, Honolulu, State of Hawaii, to be held pending a hearing by the Hawaii Paroling Authority to determine if there is sufficient cause to warrant re-imprisonment of said parolee or any other action authorized by law.

It is alleged that the above-named parolee did violate the terms and conditions of parole in the following manner:

1. In violation of Rule #1d, parolee DELOS-SANTOS BASS did have in his possession and control methamphetamine on December 30, 2025.
2. In violation of Rule #8, Special Condition #15, parolee DELOS-SANTOS BASS failed to remain in clean and sober housing for a period of six (6) months following his release on parole.
3. In violation of Rule #1d, parolee DELOS-SANTOS BASS did have in his possession and control methamphetamine on February 15, 2026.
4. In violation of Rule #1d, parolee DELOS-SANTOS BASS did have in his possession and control methamphetamine on May 29, 2026.
5. In violation of Rule #8, Special Condition #12 (R36), parolee DELOS-SANTOS BASS failed to carry out all instructinos given to him by his Parole Officer, when he failed to participate in out-patient substance abuse treatment on May 27, 2026, and on May 29, 2026.
6. In violation of Rule #1d, parolee DELOS-SANTOS BASS had in his possession and control methamphetamine on August 22, 2026.

If you failed to keep your parole officer and the Hawaii Paroling Authority informed as to your whereabouts at all times during your parole, your parole may have been suspended as authorized by Hawaii Revised Statues section 353-66(c).
